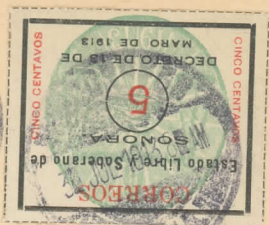

COACH SEAL ISSUE



The new stamp issue from the rebel government of Jose Maytorena was called the "Coach Seal" because the seal pictures a stagecoach. The issue consisted of stamps in value from 1 centavo to 50 centavos.

COACH SEAL ISSUE PRINTING PLATES

The sheets were composed of two panes of twenty that faced each other for a total of 40 stamps. That made two rows of 10 stamps that were tete-beche.



COACH SEAL ISSUE COLOR SHADES OF THE SEAL

There are shades of the color in the seal for the two centavos and the five centavos.

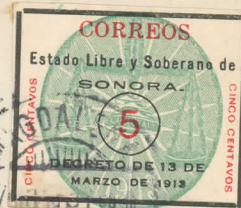

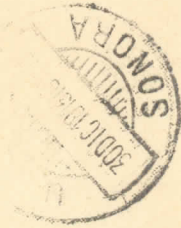

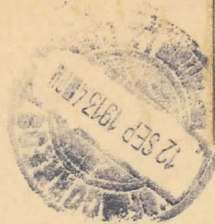
